

INTRODUCTION

Nexen 5HPSP-E Single Position Tooth Clutches are designed for applications where exact timing to two components is required..

Tooth clutches are normally engaged when stationary. In certain circumstances, such as low RPM, tooth clutches can be engaged at differential speeds up to 150 RPM. The allowable engagement speed depends on the rotational inertia of the mass being accelerated and the air pressure applied.

If the tooth clutch is to be engaged in other than static conditions, solve the following "Differential Speed" formula to make sure the application's speed is within the limits of the selected clutch.

DIFFERENTIAL SPEED FORMULA

Use the Differential Speed Formula to find the allowable engagement speed (N) at a specific air pressure setting (P) with a given inertia load (WK²). This formula expresses the relationship of the variables involved that effect the impact of the face teeth during engagement. Tooth damage can occur when tooth velocity and air pressure settings are too high (i.e. a smaller clutch has a lower tooth velocity at any given RPM and a small clutch has less driver inertia).

$$N = \frac{V(10^4)}{(P-22)\sqrt{WK^2}}$$

Where

N = Differential RPM Limit Clutch

V = Constant for Clutch (See Table 1)

P = Operational Pressure P.S.I.

 WK^2 = referred Inertia lb. • ft^2

EXAMPLE: The required differential engagement speed using a Model 5H45P-E clutch at 60 psi is 150 RPM. (Clutch rotating at 1250, machine component at 1100). The referred inertia is 3 lb. • ft². The differential RPM limit for the clutch is:

$$N = \frac{1.4(10^4)}{(60-22)\sqrt{3}} = 213 \text{ RPM}$$

150 RPM is within the limit of the 5H45P-E operating at 60 psi with a load of 3 lb. • ft².

NOTE: Formula does not estimate:

- 1. RPM which prevents ratacheting.
- 2. Acceleration time.
- 3. Tooth stress after engagement.

CAUTION

If differential speed exceeds the clutch limitations, ratcheting of the teeth can occur that will shorten clutch life.

INSTALLATION

Nexen 5HPSP-E Series clutches have a drive flange with two bearings, a pilot diameter, and tapped holes for mounting a pulley, sprocket, or the Nexen Clutch Coupling (Refer to Sales Brochure L-20208) (See Table 2 for recommended tightening torques).



NOTE: Nexen recommends using a red anaerobic thread locking compound on Pilot Mounting Bolts.

Single Position Tooth Clutch Synchronization

The clutch keyway and one mounting hole are aligned to orient the clutch for single positioning as shown in Fig. 1. The clutch face teeth engage in one location when the clutch is activated.






CAUTION

Do not connect the Clutch in-line without using the Nexen Flexible Coupling. The internal construction of the 5H Tooth Clutches will not allow misalignment tolerances. (Refer to Sales Literature L-20208).

NOTE: Nexen's 5HPSP-E is shaft mounted using a customer supplied full length key.



Refer to Figure 2.

- Install Nexen Clutch Coupling, Bearing Supported Pulley, Sprocket, or Gear (Table 2).
- 2. Insert customer supplied key into shaft.
- 3. Slide Clutch onto shaft and customer supplied key.

NOTE: Whenever possible, arrange the input drive to the clutch through the drive flange to prevent clutch bearings from rotating unnecessarily.

- 4. Using Set Screws (Item 18 & 19), secure Clutch to Shaft.
- 5. Tighten Set Screws (Item 18 & 19) to recommended torque (See Table 3).

NOTE: Align air inlet port to the six o'clock down position to allow condensation to drain out of the exhaust port.

In severe use applications, the clutch may tend to move axially along the shaft. To prevent this axial movement, confine the clutch between shoulders, clamp collars, or insert spring pins through the shaft.

Mounting positions of Tooth Clutches may be horizontal or vertical. Nexen recommends that the Drive Flange faces up to enhance the spring return when mounting tooth clutches in the vertical position.

LUBRICATION

NOTE

Nexen pneumatically actuated devices require clean, pressure regulated air for maximum performance and life. All seals in Nexen Pneumatically operated devices are lubricated for life and do not require additional lubrication.

However, some customers prefer to use an air line lubricator, which injects oil into the pressurized air, forcing an oil mist into the air chamber. This is acceptable, but care must be taken to ensure once an air mist lubrication system is used, it is continually used over the life of the product as the oil mist may wash free the factory installed lubrication.

Locate the lubricator above and within ten feet of the product, and use low viscosity oil such as SAE-10.

Synthetic lubricants are not recommended.

Nexen product's bearings are shielded and pre-lubricated, and require no further lubrication.

LUBRICATOR DRIP RATE SETTINGS



↑ CAUTION

These settings are for Nexen supplied lubricators. If you are not using a Nexen lubricator, calibration must follow the manufacturer's suggested procedure.

- 1. Close and disconnect the air line from the unit.
- Turn the Lubricator Adjustment Knob counterclockwise three complete turns.
- Open the air line.

- 4. Close the air line to the unit when a drop of oil forms in the Lubricator Sight Gage.
- 5. Connect the air line to the unit.
- 6. Turn the Lubricator Adjustment Knob clockwise until closed.
- Turn the Lubricator Adjustment Knob counterclockwise onethird turn.
- 8. Open the air line to the unit.

SPLINE

Although the Spline has been lubricated at the factory with a high temperature, anti-seize lubricating compound, Nexen recommends periodic lubrication of this component to insure smooth clutch engagement and disengagement.

NOTE: Clutch must be disassembled to lubricate Spline (See Parts Replacement section for disassembly instructions).

FACE TEETH

Lubricate Drive Flange Assembly Face Teeth, and Drive Ring (Item 17) with "NEVER-SEEZ" or equivalent whenever visual inspection shows a need for lubrication. For breakaway applications, Nexen recommends a continual drip or mist lubrication of the Face Teeth.

AIR CONNECTIONS

Although Nexen 5HPSP-E Enclosed Tooth Clutches are air actuated with a maximum operating air pressure of 80 PSI, use only enough air pressure to deliver ample torque for the application. Operating air pressures over 80 PSI will eventually cause bearing and seal damage.

Due to bearing seal drag, the cylinder/piston assembly will rotate, resulting in hose breakage when clutch is engaged. Resting the hose against a support mounted parallel to the clutch centerline stops this rotation.



CAUTION


Rigid pipe or tubing when connected directly to the clutch will prevent proper actuation of the clutch. Use only flexible hose or tubing when making air line connections to clutch.

All Nexen pneumatically actuated devices require clean and dry air, which meet or exceeds ISO 8573.1:2001 Class 4.4.3 quality.

- NOTE -

For quick response, Nexen recommends a quick exhaust valve and short air lines between the Control Valves and the product. Align the air inlet ports to a down position to allow condensation to drain out of the air chambers of the product.

The following is a common air supply scheme used with this product. This is an example and not an all-inclusive list. All air circuits to be used with this product must be designed following ISO 4414 guidelines.

PARTS REPLACEMENT

DISASSEMBLY

Refer to Figures 3 & 4.

1. Remove Set Screws (Item 18 & 19).

- Remove Retaining Ring (Item 14).
- Fully supporting lip of Drive Flange Assembly (Item 10), press Hub (Item 1), and Piston/Cylinder Assembly out of Drive Flange Assembly.
- 4. Remove Rotary Seal (Item 4).
- 5. Remove Retaining Ring (Item 14).
- 6. Fully supporting Cylinder/Piston Assembly, press Hub (Item 1) out of Cylinder/Piston Assembly.
- Remove Compression Springs (Item 8) and Spring Pin Stiffeners (Item 24).







- 4. Apply Loctite® 680 to O.D. of new Bearings, and press new Bearings into Drive Flange Assembly (Item 17).

NOTE: When installing new Bearings, carefully align Bearing O.D. with Drive Flange Bore to prevent Bearing misalignment.

BEARINGS (Items 11 & 12) Cylinder/Piston Assembly

Refer to Figures 6 - 9.

- 1. Remove Drive Flange (Item 22).
- 2. Separate Piston (Item 3) from Cylinder (Item 2).
- 3. Press Bearing (Item 11) out of Cylinder (Item 2).
- 4. Clean bore of Cylinder (Item 2) with fresh safety solvent.
- 5. Apply Loctite® 680 to O.D. of new Bearing (Item 11) and press Bearing into Cylinder (Item 2).

NOTE: When installing new Bearing, carefully align Bearing O.D. with bore of Cylinder to prevent bearing misalignment.









- Apply Loctite® 680 to O.D. of new Bearing (Item 12) and press Bearing into Piston (Item 3).



REASSEMBLY

Refer to Figures 10 - 14.

- Coat O-Ring contact surfaces of Piston (Item 3) and Cylinder (Item 2) with a thin film of O-Ring lubricant.
- Coat O-Rings (Items 15 & 16) with a thin film of O-Ring lubricant.
- Install O-Rings (Items 15 & 16) and Back-up rings (Items 20 & 21) on Piston (Item 3) and Cylinder (Item

NOTE: When installing new O-Rings and Back-up Rings, make sure curved surface of Back-up Ring matches surface of O-Ring. Back-up Rings must be installed on the non-pressurized side of the O-Rings.

4. Press Piston (Item 3) into Cylinder (Item 2).

NOTE: Use caution when pressing Piston into Cylinder to avoid damaging O-Rings.

- 5. Slide Drive Flange into Cylinder Bearing (Item 11).
- 6. Install Spring Stiffener Pins into Drive Flange.
- Install Compression Springs (Item 8) over Spring Stiffener Pins.
- Coat Hub Spline Teeth (Item 1) with 'NEVER-SEEZ'[®].
- 9. Slide Hub (Item 1) into Drive Flange.


- 10. Install Retaining Ring (Item 14).
- 11. Install Rotary Seal (Item 4) into groove in Cylinder.



The parties expressly agree that the price for the Products and the services was determined in consideration of the limitation on damages set forth herein and such limitation has been specifically bargained for and constitutes an agreed allocation of risk which shall survive the determination of any court of competent jurisdiction that any remedy herein fails of its essential purpose.

Inspection

Buyer shall inspect all shipments of Products upon arrival and shall notify Nexen in writing, of any shortages or other failures to conform to these terms and conditions which are reasonably discoverable upon arrival without opening any carton or box in which the Products are contained. Such notice shall be sent within 14 days following arrival. All notifications shall be accompanied by packing slips, inspection reports and other documents necessary to support Buyer's claims. In addition to the foregoing obligations, in the event that Buyer receives Products that Buyer did not order, Buyer shall return the erroneously shipped Products to Nexen within thirty (30) days of the date of the invoice for such Products; Nexen will pay reasonable freight charges for the timely return of the erroneously shipped Products, and issue a credit to Buyer for the returned Products at the price Buyer paid for them, including any shipping expenses that Nexen charged Buyer. All shortages, overages and nonconformities not reported to Nexen as required by this section will be deemed waived.

Limitation on Actions

No action, regardless of form, arising out of any transaction to which these terms and conditions are applicable may be brought by the Buyer more than one year after the cause of action has accrued.
